

Show Rules

1. All exhibitors must wear ASTM/SEI protective helmets with harness fastened at all times while mounted on the show grounds. Proper attire is requested.
2. Entries will not be accepted without a signed entry from release.
3. Points will be counted 10, 6, 4, 2, 1, .5 Champion 10, Reserve Champion 6. With bonus points for associate shows.
4. Exhibitors show at their own risk.
5. Food will be available on grounds.
6. all exhibitors ***MUST*** present a current negative Coggins Test .
7. Participants and spectators alike understand that horses are inherently unpredictable and dangerous and that equipment and ground conditions are equally unpredictable; yet knowingly choose to participate and/or spectate, taking responsibility for this choice. Entry onto the grounds constitutes knowledge and agreement with this policy.

DIVISIONS:

Leadline: Open to riders 7 years and younger as of Dec. 1 of the current show year. Riders not allowed to cross enter into any trot classes. To be judged 50% equitation and 50% suitability. BHSA

Pre Short Stirrup: Open to riders 10 years and under as of Dec. 1 of the current show year. Riders may not cross enter into canter or jumping classes. 10 years or younger. BHSA

Short Stirrup Hunter: Open to riders 12 years and under as of Dec. 1 of the current show year. Riders may not cross enter into classes with jumps higher than 18". Courses may be trotted. VHSA

Short Stirrup Equitation: Open to riders 12 years and under as of Dec. 1 of the current show year. Riders may not cross enter into classes with jumps higher than 18". Courses may be trotted. BHSA

Long Stirrup Equitation: Open to riders 13 years and Older as of Dec. 1 of the current show year. Riders may not cross enter into classes with jumps higher than 18". Courses may be trotted. BHSA

Limit Rider Hunter: Open to horses/ponies ridden by Juniors/Adult Amateurs. Riders may not cross enter into Equitation over fences classes or any class with fences 2'6" or higher. Ponies must be ridden by juniors. Horses and ponies may cross enter. Jump Height 2' or 2'3" BHSA

Pony Hunter: Open to Ponies 14.2 hands & under ridden by juniors. Jumps: Small 2'; Medium 2'3'; Large 2'6". Small and medium ponies to jump 2'; large ponies to jump 2'6" BHSA VHSA

Pleasure: open to all *will be split Children's, Adult, and pony if entries warrant Judged on manners, suitability, soundness and way of going. BHSA VHSA

Child/Adult Am Equitation: Fences 2'6" or 3' *will be split if entries warrant BHSA VHSA

Child/Adult Am.: Fences 2'6" or 3' *will be split if entries warrant

Working Hunter: Open to all Horses, and Ponies not showing in any Pony Division. 3' or 3'3" BHSA VHSA

Green Hunter: Open to Horses in their 1st or 2nd year of showing over fences 2'6" or higher and Ponies in their 1st year of showing at 2', 2'3", 2'6" or higher. Will be split if entries warrant. Open to horses in their first or second year of showing. Fences 2'6" or 3' BHSA VHSA

Schooling Hunter: Open to Horses and Ponies; no restriction on riders. Minimum Jump height is 2'6"; not to exceed 3'. BHSA

Low Hunter: Open to Horses and Ponies; no restriction on riders. 2'. BHSA

In connection therewith, I agree as follows: Every entry in this equine activity shall constitute and agreement and affirmation that all participants (which include without limitation, the owner, lessee, trainer, manager, agent, coach, rider, handler, and the horse), for themselves, their principals, representatives, employees and agents agree that they participate voluntarily, are fully aware that horse sports and competition involve inherent risk of serious injury or death, including the propensity of equines to behave in dangerous ways which may result in injury, understand the inability to predict an equine's reaction to sound, movements, objects, persons or animals, and recognize the hazards of surface and subsurface conditions, and by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold the activity management, employees, owners, volunteers, and affiliates harmless from and against all claims, including injury or loss suffered during or in connection with the competition whether or not such claim, injury, or loss resulted directly or indirectly from the negligent acts or omissions of said officials, directors, employees, volunteers, or agents of The Barracks.

I have fully read and fully understand the foregoing equine liability release, waiver of right to sue and assumption of all risks and hereby execute this release, waive the right to sue and assume all risks of injury or death to the fullest extent allowed by the Virginia Liability Act (Va. Code 3.1-796.130 through 3.1-796.133).
